This is more than just offering a venue; it's about supporting your organization in hosting powerful, mission-driven events that bring people together, elevate your work, and help you make a lasting impact in the community.

**Applications Due for First Review** March 3, 2025, by 5:00 pm PDT

**First Awards Announced** March 31, 2025

**Final Awards Announced** September 30, 2025

### FUNDING AVAILABLE

Up to \$150,000 is available for the 2025 cycle, in grants up to \$25,000 of in-kind facility and event services.

community-led initiatives without nonprofit status

- Firm certified by the Oregon Certification Office of Business Inclusion and Diversity (COBID):
  - Minority Business Enterprise (MBE)
  - Women Business Enterprise (WBE)
  - Veteran Business Enterprise (VBE)
  - Emerging Small Business (ESB)
- Events attracting over 200 attendees will be prioritized.
- An organization may submit multiple applications but is only eligible for one grant per cycle.

### FUNDING REQUIREMENTS

- Event must occur between April 1, 2025, through June 30, 2026, at the OCC.
- Awardees are required to carry general liability insurance for the event period.
- Applicants must not have hosted their proposed event at the OCC within the last five (5) years.
- Events currently under contract (signed before March 3, 2025) are **not eligible.**
- Campaign and proselytizing activities are **not eligible.**

### RESTRICTION ON USE OF FUNDS

• In-kind funding for OCC facility rental and services only, no cash awards.

- Materials and services not tied to the OCC event license agreement, or more than funds awarded.
- OCC will make every effort to accommodate preferred event date(s) and spaces. If your event has a firm date or preferred space, please email <u>SpaceToGrow.org</u> to check availability.

### CONTRACTING AND AGREEMENTS

Application of awarded funds will be applied to the client's invoice at the close of the event. **Award recipients enter into a License Agreement with the OCC.** 

Recipients must also comply with all applicable requirements and laws related to event operations, safety and security, food handling, and other obligations outlined in these agreements. Insurance coverage

OCC requires event hosts to secure a certificate of insurance at a minimum \$2 million comprehensive general liability insurance covering the event period through a company such as <u>Gather</u> <u>Guard</u>.

# **REVIEW** PROCESS



### **REVIEW TEAM**

Our review team includes OCC staff representing a breadth of roles within the sales and executive divisions; leadership from the Metropolitan Exposition and Recreation Commission (MERC) which manages and protects the public investment of select regional facilities including OCC; seasoned staff from our affiliate partner, Travel Portland; and gracious participation from focus group participants who were convened spring 2024 and whose efforts led to the development of the Space to Grow Fund.

### OBJECTIVES

The Space to Grow Fund aligns OCC's mission with our racial equity plan by incorporating community feedback and developing resources that make hosting local events at OCC more accessible.

As we launch this inaugural funding year, we are committed to adapting and refining our approach based on ongoing insights to better support the needs of our community partners.

#### Equity

Resource communities of color and other historically marginalized communities through the following.

- Directly benefit people of color or members of other historically marginalized communities
- Led by or actively supported by communities of color or other historically marginalized communities

- Strengthens cultural and community assets
- Provides opportunities for expression of culture

#### Impact

Increase cultural, community, or growth outcomes

- Event growth in size, scope, or reach
- Increase number of regional cultural events
- Supporting local opportunities to convene, collaborate, and celebrate
- Community investment through education, leadership development, and fundraising

#### Feasibility

Support event readiness by providing tools, resources, and assistance to applicants.

### SCORING GUIDE AND RUBRIC

Scoring categories are weighted equally to ensure a balanced assessment. Excluding eligibiliy, a total possible score is 35 points.

- Applicants with a score of 30+ points are highly recommended for funding.
- Applicants scoring 20-29 points are recommended for further consideration or partial funding
- Applicants scoring below 20 points are not recommended for funding.

# **REVIEW** PROCESS



Each application will be reviewed based on the following criteria.

CRITERION	SCORE RANGE	SCORING DESCRIPTION
Eligibility	Pass/Fail	Must meet geographic and event-specific requirements to qualify.
<b>Equity</b> Event goals and methods for measuring their success.	0-5	<ul> <li>5: Event goals include people of color or members of other historically marginalized communities including examples and measurable actions.</li> <li>3: Some commitment but lacks specific measures or examples.</li> <li>0: No evidence of equity efforts.</li> </ul>
<b>Impact Potential</b> Impact of funding select, narrative	0-5	<ul> <li>5: High potential for cultural, community, or growth-related impact.</li> <li>3: Moderate impact but less clearly articulated.</li> <li>0: Low or no impact.</li> </ul>
<b>Feasibility and</b> <b>Readiness</b> Mission, event experience, audience, marketing	0-5	<ul> <li>5: Clear readiness: realistic audience/attendance strategies, and event experience.</li> <li>3: General feasibility but lacks detail or unclear strategies in achieving goals.</li> <li>0: Unrealistic or absent readiness plan.</li> </ul>
Accessibility and Inclusion Accessible and inclusive	0-5	<ul> <li>5: Well-defined and strong accessibility and inclusivity plans.</li> <li>3: General plans but lacking specifics.</li> <li>0: No clear accessibility or inclusivity plans.</li> </ul>
<b>Budget</b> Event budget, breakdown, funding request	0-5	<ul> <li>5: Budget reflects awareness of OCC event-related facility and service costs. Total event budget is reasonable by showing how costs will be covered.</li> <li>3: Lacks specificity of OCC event-related costs and minimal details in breakdown of cost categories.</li> <li>0: Unrealistic budget details or no budget details.</li> </ul>

# AWARDS



### AWARD ANNOUNCEMENT

One-third of the program funds (up to \$50,000) will be disbursed at the first award announcement, with the remaining two-thirds (up to \$100,000) awarded at the final announcement of the cycle to ensure a balanced application period.

Award recipients must submit a postevent outcomes report via in-person/ virtual meeting, written summary, or an optional feedback survey. Meetings cover event goals, community impact, and equity measures.
